Roscan Gold Announces Option Grant

Toronto, Ontario. – June 28, 2022 – Roscan Gold Corporation ("Roscan" or the "Company") (TSX- V: ROS; FSE:20J; OTC:RCGCF) announces that it has granted 3,276,037 stock options to purchase common shares of the Company exercisable at a price of \$0.34 per common share and expiring on June 28, 2027 to a director of the Company. The common shares issuable upon exercise of the options are subject to a four-month hold period from the original date of grant.
